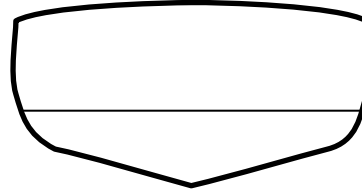
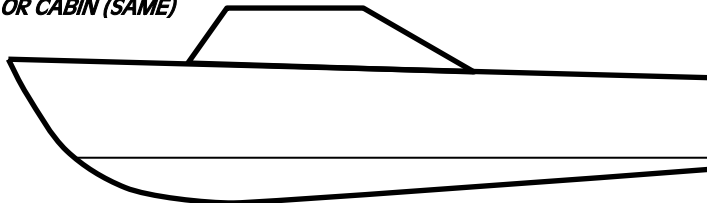

required for Designs including Graphics. This includes 2 updates/changes, if needed. Additional proofs are **\$20.00** for lettering and **\$35.00** for graphics and added to the final price.

\$100.00
required to cover cost of purchasing Custom Fonts. We have over 4000 Free Fonts on hand. This deposit is included in your final price.

\$150.00
required to cover cost of all Four Color Printed Proofs. There are **NO FREE** Updates - Additional proofs are **\$75.00** and added to the final price.

If this lettering job is cancelled or postponed after additional proofs, you are still liable for unpaid Design charges.

PAYMENT - Due on receipt of Invoice, unless other provisions have been agreed and arranged prior to installation. Dealers working as agents for their customers to attain names for “undelivered” vessels have a 2 week grace period from date of installation. An Invoice, complete with photo of lettering installed (if attainable) will be provided either by email or in person within 72 hours.

VINYL - JEFFQUEST GRAFIX & DESIGN is **not responsible** for creating lettering that was ordered incorrectly, all efforts will be taken to resolve any problem in a timely manner*. In addition, we are not responsible for problems arising after installation, due to owner neglect or unforeseen circumstances.

4 COLOR “PRINTED” VINYL - JEFFQUEST GRAFIX & DESIGN offers our customers a printed four color option, similar to vehicle wraps. Your Name and or Graphics are Printed on White Vinyl and then installed as one piece. All four color printed names are priced per size and complexity. Some additional charges may be added for installation on colored hull. Order may take additional days to complete as vinyl printing is done at our second location. No Guarantees on fading.

PRIOR NAME REMOVAL – It is suggested that you make this request of your Dealer/Marina or Brokerage. Boats requiring prior names be removed by JEFFQUEST GRAFIX & DESIGN will be billed at a rate starting at **\$200.00** per man hour to remove Vinyl lettering and all residual glue. We **DO NOT** remove painted names due to the use of harsh chemicals, and you should make arrangements at your local Marine Facility or Dealer to do so.

INSTALLATION – The original request date (Today's Date) must be a minimum of 3 days prior to date of installation (Date Needed), otherwise, at the discretion of **JEFFQUEST GRAFIX & DESIGN**, a rush charge may be added depending on complexity of request. Weather permitting, Installation will be performed on or near the “needed” date* as described on page 1.

NO INSTALLATION – For Customers or Dealers who prefer to install their own lettering. The cost of vinyl, proofs, graphics, and delivery remain the same. There is no discount for multiple names. JEFFQUEST GRAFIX & DESIGN is not responsible for problems or errors that arise during installation, with the exception of unproduced vinyl. Additional Vinyl is available at the same vinyl cost plus delivery. Installation Supplies Available at additional cost.

COPYRIGHTED MATERIAL – The Boat Owner or Dealer claims full responsibility for all requested and installed Graphics, Logos, Likenesses, Cartoon Characters, Quotes or Catch Phrases that have been previously Registered or copyrighted by an outside Person or Company that appear as part of the lettering on this boat.
